

OID Earning Limits 2023/2024 - Correction

It has been noted that two different OID earning limits were published by the Department of Employment and Labour for the 2023 year (March 2023 - Feb 2024). It has now been confirmed that the earnings threshold is R568 959, click<u>here</u> for more information.

The Director General of Employment and Labour published a Government Notice extending the deadline for the 2022 Return of Earnings (Financial year 2022/2023) submission from 1 April 2023 to 31 May 2023.

South Africa - Low or Interest Free Loan/Debt Fringe Benefit - New Repo Rate Effective April 2023 The repurchase rate (repo rate) has increased from 7.25% to 7.75% on 30 March 2023. As from April, the 'low or interest free loan/debt' fringe benefit should be calculated by using the new 'official interest rate'.


